
Although my curiosity was killing me, I thanked Paul and Laura, set it aside, and continued enjoying the day – and Lilly. The computer thumb drive contained 5 executable files entitled: CHALLENGE 1 CHALLENGE 2 CHALLENGE 4 CHALLENGE 5 CHALLENGE 6

I thought I'd get an early insight into what this "CHALLENGE" thing was all about, so I attempted to open file "CHALLENGE 1". NO LUCK

The files were password protected!

I was instructed to open only 1 envelope at a time. The next day, at home, I opened the "CHALLENGE 1" envelope.

to open an encrypted archive one needs a password. (Yeah, no kidding.)


Without knowing exactly <u>what</u> I was going for, I headed for the Fayetteville library...

UPC of metal book at the library gazebo....



The UPC was obviously "18907001". What that meant, I DIDN'T KNOW.

Next of kin, lowell (gunsid???), page twenty eight....




The top transparency boxes lined up on page 28 of the book "<u>Next</u> of Kin" by Lowell Dingus, and read:

The clue you seek resides with Georgene.

I called Georgene. We agreed to meet the next day at Red Lobster where she would provide me with the next clue (Paul had mailed it to her).



Georgene at Red Lobster with the new clue and transparency (even when she has the clue – she HAS NO CLUE) Me at Red Lobster simultaneously attempting to solve the latest clue on the laptop and tempting the lobsters with my finger.



Georgene's clue. A bunch of garbled gibberish at the bottom.

Original transparency

When the original transparency was placed over Georgene's gibberish clue, the following message appeared:

The password is: upcmod13579

We tried using the password "upcmod13579" as the password to access the "CHALLENGE 1" file on the thumb drive.

NO LUCK

We were, of course, omitting the UPC number obtained at the library. Maybe substitute the upc number "18907001" obtained at the library for "upc" in the password – for a real password of: "18907001mod13579"

NO LUCK

Although we were half way there with our attempt at substitution, two University of Illinois engineers couldn't see that the password clue (upcmod13579) was actually a mathematical equation. (It took a hint from Paul to set us down this trail). Once we viewed the password as a mathematical equation [(UPC) MOD (13579)], we (alright – Georgene) suggested that we enter the two numbers (18907001 and 13579) into the MOD function in Excel. The result of the mathematical function was "5033".

PROMISING...

When we used "5033" as the password, we gained admittance to the file and obtained the below sheet. It contained the picture of a building and driving directions to some location in downtown Atlanta.





Go north on I-75/I-85 to downtown Atlanta. Take exit 248C Freedom Parkway (GA 10 East). Go 1.7 miles to Ponce de Leon Avenue and turn right. Go 1.7 miles to Clifton Road and turn left. Go 1/10 mile to the entrance and turn right. We braved the Atlanta traffic and, with Georgene as the navigator, followed the driving directions. The final destination was the Fernbank Museum of Natural History. We parked and went inside the lobby – looking for something that we might recognize as the next clue. After several minutes of nothing, Georgene noticed a

man in front apparently looking for someone. Thinking he may be one of Paul's cohorts, I approached him and said; "Looking for someone?" Taking a half step backward, with anxiously looking for an escape route or for a weapon to defend himself, he said; "I'm just waiting spied Paul, Laura and Lilly! What a treat! I used the debit card to obtain museum tickets and the five of us spent the rest of the afternoon enjoying the museum exhibits. Lilly was excellent all day long – and I got to carry her most of the time!!










After FOUR HOURS of trying to unsuccessfully solve the Sudoku puzzle I decided to see if the web could offer me any assistance – before I wrought any permanent damage to the nice wooden Sudoku board that Tammy had given me for Christmas.

The web solved the puzzle in 0.4 seconds.

By converting the alpha-numerics on the bottom of the clue sheet to numbers from the completed Sudoku grid, and then converting those numbers to a letter using the A=1, B=2, C=3... format, the following message appeared:

YOUR FIRST CLUE IS UNDER A STONE AT THE POND

It was off to the backyard pond....



The backyard pond (with the rock removed from atop the clue)

Under a rock, a baby food jar with a small slip of paper that said "CHALLENGE 2"



On the reverse of the small piece of paper was the word "fishes".

Some clue! Where should "fishes" guide me?....



Inside the pond... (I would have though that Paul would use "frogs" if he was directing me into the pond, but I tried anyway.) Although this is Atlanta, the water's still pretty cold in late December!

NO LUCK

The fishes mobile over Lilly's crib... I was sure this was it. I inspected every inch of every fish for a clue. I even searched Lilly's entire crib.

NO LUCK





A fishes puzzle on the puzzle wall of the downstairs den...

NO LUCK

Fishes on the various hand soap dispensers throughout the house...

NO LUCK



A half-discarded fishes flower pot in the back yard... NO LUCK I spent a day and a half searching the entire house – upstairs and down – inside and out - with the word "fishes" on the tip of my tongue, looking for anything that might look like a clue...

NO LUCK

I finally thought that maybe "fishes" was actually the password for the encrypted "CHALLENGE 2" file. Nah, Paul's too sadistic for that. But I searched the entire house and yard several times over and came up with nothing. Maybe it's worth a try...

Sure 'nuff – it was the password! The following sheet was obtained:



The completed second Sudoku puzzle. I only spent 3 hours unsuccessfully trying to complete it this time - before I went to the web. (It's not cheating - it's an intelligent use of available resources!) A similar alpha-numeric to number conversion using the second completed Sudoku grid provided coordinates of:

The walking instructions did become apparent when we got to the coordinates!




They were concrete marker numbers in the brick walkway identifying the Section number of the brick paths (to aid in finding a particular engraved brick). We followed the sequence of Section numbers until it led us to the edge of the park, right across the street from the Georgia Aquarium - where we spied Paul, Laura and Lilly.



While at the Centennial Park we looked up the "1995 Malone Family Reunion" walkway brick that Georgene had obtained in Section 26.

I used the debit card to purchase tickets (I got the senior's discount) and spent a delightful day at the Aquarium.

<u>Contents</u>: A sheet with letters and numbers making no sense at all, with a "Final Destination:" coordinate at the bottom making even less sense. Also included: A wheel with a spinning inner wheel with numbers and letters on it.

After many false starts and much spinning of the wheel, I discovered that when the letter "T" of the outer wheel lined up with the number "3" of the inner wheel, a sensible correlation between the gibberish on the page and what even Paul would consider reasonable English – appeared. Letter by letter the scrambled letters/numbers was decoded as:

Gibberish. Hopefully this text won't turn into gibberish from being too cold. For the next leg of your adventure you will have to journey to Centennial Park. The coordinates of your final destination are listed below, but to hide its location from others it has been encoded. I hid the cypher in your coke freezer. The cypher should help you decode the final destination, but I forgot one of the coordinates. Hopefully you can figure it out. Gibberish, did it turn into gibberish? I went to the garage refrigerator where we keep soft drinks. In the freezer section (which needs defrosting, by the way) was a baby jar labeled "Challenge 3"...



Inside the baby jar was a small piece of paper that assigned a coordinate to all but one of the symbols used in the "Final Destination" cypher.

Solving for the "Final Destination" is not going to be as straight-forward as I thought it might be...

After a lot (probably too much) of mathematical thought and manipulation (I felt I had to make up for my slight mathematical short-coming in CHALLENGE 1), I finally decided that since the original clue mentioned going to the Olympic Centennial Park, I might go to the park - specifically to the coordinates assigned to each of the symbols (all of the coordinates are fairly close together – probably all within the park) and see if, when I get there, the location somehow correlates with a specific number.

Maybe they might direct me to specific concrete Section walkway marker numbers that I discovered in Challenge 2!

It's probably worth a try. Mathematics certainly ain't gettin' me nowhere!

It's off to the Olympic Centennial Park in downtown Atlanta – with my GPS tracker – and Georgene in hand...

I sent this sheet to Georgene to see if she could help me solve for the variables and for the "Final Destination" coordinates.


Because the Final Coordinate has to be: N 33° 45 (+ some decimal fraction)' W 84° 23 (+ some decimal fraction)'

All the symbols must somehow convert to a single number, probably an integer, because of the "(1000 -)" and "(800 -)" portions of the equations.

Or not....?

Any ideas??

When we got to the first variable's coordinate, the method to identify the variable's value became obvious...



Since, if the final destination is in the Atlanta area, the latitude must be N33°. Therefore, + must equal 33. Since is 1, then is 32.

These Final Destination coordinates put us at the World of Coca Cola Museum just north of the Olympic Centennial Park.

There we met up with Paul, Laura and Lilly and went through the museum. We got our fill of coke and different Coke drinks from around the world.







Go directly to Piedmont Park, do not pass go, do not collect two hundred dollars. Match the inscriptions with the coordinates to get the password of the encrypted file for your next clue. Don't forget your locked box or your computer.

Head North on I-75/I-85 Take exit 250 toward Georgia Tech/Tenth St/Fourteenth St Merge onto Williams St NW (377ft) Turn Right at 10th St NW (1mi)

Parking as well as the traffic can be quite poor. You should see Piedmont Park on your left on Tenth Street and eventually the Grady High parking lot on your right toward the end of the park. Park wherever you can near the park.

Contents: (above) Instructions to go to Piedmont Park to match (on right) the inscriptions with the coordinates on the bottom of the page to get the password for the next clue. It reminded me to bring along my laptop computer and the "locked box".

It was off (with Tammy in tow) to Piedmont Park in downtown Atlanta....

It was a beautiful, sunny, January day. In the 60's. I had a great time traversing the park (it was quite large – with two small lakes). Tammy enjoyed watching all the people in the park (mostly their dogs).

I used the GPS navigator to one by one locate the coordinates given. Once at the coordinate, I looked for something that resembled the given inscriptions. Low and behold, once I got to a coordinate the "inscription" was obvious. It was a dedication inscription on a park bench, swing or a fountain.





Once I matched up all the coordinates with the number associated with each inscription, I arrived at the password:

4091856732

When I entered the password for the encrypted Challenge 4 file, the following appeared. It instructed us to proceed to the High Museum of Art for additional clues.

CHALLENGE 4

You have to gather a few more clues before you can leave downtown. Your next destination is the High Museum of Art. There you will gather the rest of the needed clues to open the locked box you have with you. I would drive opposed to walk, but it is only 1.2 miles away depending where you parked. Head west on 10th street back toward I-85. Take a right on Peachtree St NE. The museum should be on your left. You can usually find parking on 16th street. Though you are not required to purchase a ticket to the museum to gather the clues, you may want to if you have the time.



The third # was 1996 – 1919 – 48 = 29

After finding the information at the High Museum of Arts, and after a few math calculations, I discovered the combination to the "locked box" to be...

25 - 03 - 29

I still didn't exactly know what to do with this. The original directions reminded me to bring the computer and "locked box" with me to Piedmont Park. I thought the "locked box" referred to the computer thumb drive with the encrypted (locked) files on it. This is where Tammy's complicity in this part of the Challenge arose. She directed me to a "locked box" hidden in the back of the car...



It was a suitcase locked with a combination lock.

I used the newly obtained combination to open the lock. In the "locked box" were dress clothes (slacks, shirt, socks & shoes, sport jacket and a dress) and the following directions:


After briefly arguing over who was going to get to wear the dress, we changed clothes and proceeded to follow the directions...


It was a cold January day – about 20° . It had snowed last night and there was still some snow on the ground.



When I got to the given coordinates at the Olympic Park, the walking numbers made sense. They were Section numbers in the brick walkway....








The Section markers led me through the entire park.

After following all the Section markers to the end (#2), I was at the edge of the park – directly across the street from the CNN Center (address 190). Following the directions I went up the left stairs and spied a directory map. The final destination (#265) was Jock's and Jill's sports bar/restaurant where Paul and Laura were waiting with three tickets to the Atlanta Thrashers Hockey game that day at 2:00 pm. We had lunch at Jock's and Jill's and went to the Thrasher's game in Phillip's Arena (adjacent to CNN Center). The Thrashers lost, 4 - 1, in true Atlanta sports tradition.



It directed me to the next clue in a hollow tree, but the coordinates of the tree are encoded by several riddles/ problems.

The answers to the problems are inserted in red.

(I had problems with variable 'y'. It seems that Paul mistakenly believes that people other than Electrical/Electronic engineers care anything about "non-inverting amplifiers". I gave the problem to Georgene who had one of her Electronic Engineer flunkies at work solve it for me.) Plugging the variable numbers into the coordinate equation gave me the coordinates of the hollow tree:

The coordinates led me to the clubhouse area of our Royal Ridge subdivision where I spied a hollow tree...







Inside the hollow tree, and under some leaves, was a baby jar with a slip of paper that said "CHALLENGE 6". On the reverse side of the slip of paper was the word "monkeys".



"monkeys"... The only thing I could think of was Lilly – the way she just recently started to crawl about and climb over everything. But then I remembered the day and a half I spent in CHALLENGE 2 looking for "fishes"...

I saved a day and a half this time. "monkeys" was the password to the CHALLENGE 6 encrypted thumb drive file that yielded:



Your next stash is hidden within the picture below. Your job is to find out where this is and where the stash is hidden. Drive up GA-85 using your GPS for when to turn off. You will not go as far as Riverdale before you should turn to reach the following coordinate.



I entered the coordinate in my GPS tracker and found that the location of the coordinate was about 4.6 miles north of the house. I got in my car and headed north...

The GPS led me to a parking lot immediately in front of the Fayetteville Pet Smart store.





Inside the Pet Smart store I found the spot from which the original picture was taken.
